

ORDINANCE NO. 304

LEVYING TAXES ON REAL PROPERTY FOR THE YEAR 1976 IN THE BOROUGH OF NORTHUMBERLAND, NORTHUMBERLAND COUNTY, PENNSYLVANIA, AND CONTINUING THE PROVISIONS OF ORDINANCES NO. 220 AND 221, ADOPTED MARCH 3, 1964, WHICH ORDINANCE LEVIED A PER CAPITA TAX OF \$5.00 A YEAR AND LEVIED A TAX ON EARNED INCOME OF THE RESIDENTS OF THE BOROUGH OF NORTHUMBERLAND: AND CONTINUING THE PROVISIONS OF ORDINANCE NO. 267 APPROVED DECEMBER 29, 1972, KNOWN AS OCCUPATIONAL PRIVILEGE ORDINANCE.

BE IT ENACTED AND ORDAINED by the Borough of Northumberland in Town Council assembled, and the same is hereby enacted and ordained by the authority of the same.

SECTION 1: That in accordance with section 1302 of the Borough Code, a tax of seventeen mills on the valuation of real property as assessed for County purposes is hereby levied for general Borough purposes for the year 1976 on all properties made taxable by the laws of the Commonwealth of Pennsylvania for County rates and levies. The total levy amounts to seventeen mills.

SECTION 2: The Provisions of Ordinance No. 220 approved March 3, 1964 which ordinance levied a per capita tax of \$5.00 per year is hereby continued for the year 1976 all provisions of the ordinance shall be continued and are adopted by reference.

SECTION 3: The provisions of Ordinance No. 221, approved March 3, 1964 which ordinance is known as the "Earned Income Tax Ordinance" is continued for the year 1976, and for successive years or until said ordinance has been revoked or annulled, all provisions as set forth in said ordinance shall be continued and are adopted by reference.

SECTION 4: The provisions of Ordinance No. 267 approved December 29, 1972 which ordinances is known as the "Occupational Privilege Ordinance" is continued for year 1976, and for successive years or until said ordinance has been revoked or annulled, all provisions as set forth in said ordinance shall be continued and are adopted by reference.
