

ORDINANCE NO. 308

AN ORDINANCE AUTHORIZING THE DIRECTING OF THE CONSTRUCTION OF A SANITARY SEWER ON SUSQUEHANNA ROAD FROM FIFTH STREET IN THE BOROUGH OF NORTHTHUMBERLAND, PENNSYLVANIA, AND EXTENDING IN A NORTHWESTERLY DIRECTION A DISTANCE OF 1004 FEET AND ALSO ASSESSING THE ABUTTING PROPERTY OWNERS ON SAID STREET

BE IT ENACTED AND ORDAINED by the Borough of Northumberland in Town Council assembled and it is hereby enacted and ordained by authority of the same.

Section 1. It is hereby directed that a sanitary sewer shall be constructed on Susquehanna Road in the Borough of Northumberland, Pennsylvania from Fifth Street in a northwesterly direction a distance of 1004 feet. The work shall be done by contract and awarded to the lowest and best bidder.

Section 2. The cost and expenses of the entire work on Susquehanna Road shall be paid by the Borough of Northumberland and the owners of real estate bounding or abutting on said street in accordance with the Act of February 1, 1966 P.L. No. 581 Section 2003; at least $\frac{3}{4}$ of the cost of the sewer shall be paid by the Borough of Northumberland, the same is hereby appropriated herefore out of the funds now or hereafter in the treasury and the balance of $\frac{1}{4}$ of the cost of the sewer shall be paid by the owners of the real estate abutting or bounding on said street, and the same is hereby assessed and the assessments appropriated therefore.

Section 3. All ordinances or resolutions or parts thereof inconsistent herewith be and the same are hereby repealed.

Section 3. All ordinances or resolutions or parts thereof inconsistent herewith be and the same are hereby repealed.
