

NOW, THEREFORE, BE IT RESOLVED by the Council of the Borough of Northumberland and it is hereby resolved by the Authority of the same that the President of the Borough Council is hereby directed to execute said Cooperation Agreement and the Borough Secretary is authorized to attest to it.

RESOLUTION OF THE COUNCIL OF THE BOROUGH OF NORTHUMBERLAND
ON THE CENTRAL NORTHUMBERLAND REDEVELOPMENT PROJECT

RESOLUTION NO. 315

WHEREAS, the Planning Commission of the Borough of Northumberland has certified the area known as the Central Northumberland Redevelopment Project a description of which is attached hereto, and

WHEREAS, the Redevelopment Authority of the County of Northumberland desires to undertake the development of said area, and

WHEREAS, the Redevelopment Authority of the County of Northumberland wishes to obtain financial assistance from the Commonwealth of Pennsylvania in the amount of Two Thousand----- (\$2,000.00) Dollars, and

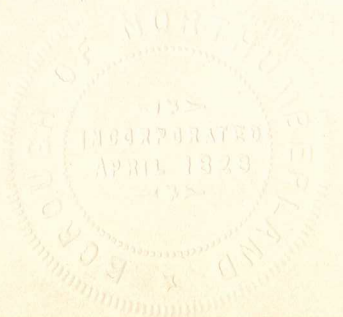
WHEREAS, the Redevelopment Authority of the County of Northumberland has prepared the attached Form DCA-20 "Application for Redevelopment Assistance Grant," and

WHEREAS, the Redevelopment Authority of the County of Northumberland has indicated in the aforesaid application for redevelopment assistance grant that certain cash and or non-cash contributions will be provided by the Borough of Northumberland, and

WHEREAS, the governing body of the Borough of Northumberland approves this statement of intent to provide local assistance when needed;

NOW, THEREFORE, be it resolved that the Redevelopment Authority of the County of Northumberland be and is hereby authorized to file the attached Form DCA-20, Application for Redevelopment Assistance Grant, for a grant in the amount of Two thousand----- (\$2,000.00) Dollars, in order to further the redevelopment program And it is further resolved that the redevelopment area as certified by the Planning Commission is hereby approved for redevelopment. And it is further resolved that the housing needs of the Borough of Northumberland can best be met by the expenditure of State funds allocated under the Housing and Redevelopment Law of 1949 as amended, in the clearance of slums and the redevelopment of blighted areas.
