ORDINANCE NO. 333

ORDINANCE ACCEPTING DEED OF DEDICATION

BE IT ORDAINED, and it is hereby ordained by the Borough Council of the Borough of Northumberland, Northumberland County, Pennsylvania, as follows:

1. The deed of dedication from Robert D. Davis and Ethel F. Davis, Marlin Tressler and Lillian Tressler, Robert Mull, Jr., and Rachael Mull to Borough of Northumberland, dated March , 1977, for the following described strip of land, is formally accepted by the Council of the Borough of Northumberland for street purposes and other purposes set forth therein: ALL that strip of land situate in the Borough of Northumberland, Northumberland County, Pennsylvania, more particularly bounded and described as follows:

BEGINNING at the intersection of the center line of Fifth Street (60 feet wide - unopened) and the center line of Susquehanna Street (33 feet wide); thence along the center line of Fifth Street north forty-five degrees nine minutes seven seconds east (N. 45° 09' 07" E.) a distance of sixteen and fifty hundredths (16.50) feet to a point; thence through the southern half of Fifth Street and along the northeastern line of Susquehanna Street south forty-four degrees fifty minutes fifty-three seconds east (S. 44° 50' 53" E.) a distance of six hundred fourteen and thirty-four hundredths (614.34) feet to a point; thence north forty-five degrees nine minutes seven seconds east (N. 45° 09' 07" E.) a distance of eight and fifty hundredths (8.50) feet to a point; thence in a line parallel with the center line of Susquehanna Street and twenty-five (25.00) feet distant therefrom south forty-four degrees fifty minutes fifty-three seconds east (S. 44° 50' 53" E.) a distance of eight hundred sixty-five and fifty-eight hundredths (865.58) feet to a point of curvature; thence on a curve to the right an arc distance of two hundred eighteen and sixty-three hundredths (218.63) feet with a radius of fifty (50.00) feet; thence on a curve to the left an arc distance of thirty and seventy-eight hundredths (30.78) feet with a twenty-five foot radius; thence in a line parallel to the center line of Susquehanna Street and twenty-five (25.00) feet distant therefrom north forty-four degrees fifty minutes fifty-three seconds west (N. 44° 50' 53" W.) a distance of one thousand four hundred nine and twenty-one hundredths (1,409.21) feet to a point in the center line of Fifth Street; thence along the center line of Fifth Street north forty-five degrees nine minutes seven seconds east (N. 45° 09' 07" E.) a distance of twenty-five (25.00) feet to the point or place of beginning.

2. The Secretary of the Council of the Borough of Northumberland is hereby authorized and directed to record the aforesaid deed of dedication in the Northumberland County Recorder's Office.
