
WHEREAS, A County Boroughs Association would further the interest of the borough and it's inhabitants; and

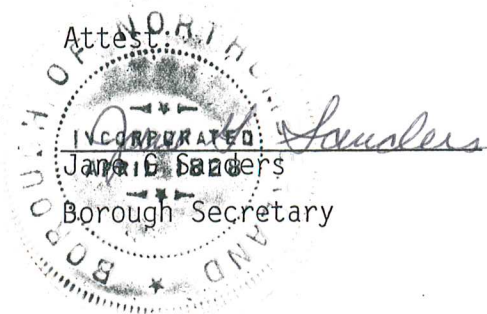

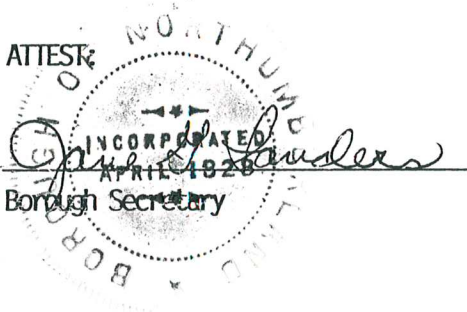
BE IT RESOLVED that at the Regular Stated Council Meeting held Tuesday,
