RESOLUTION NO. R-5-95

THE MUNICIPALITY OF BOROUGH OF NORTHUMBERLAND
PRESIDENT OF COUNCIL AND BOROUGH SECRETARY BY MEANS OF FORMAL
RESOLUTION AGREES TO COMPLY WITH PUBLIC ACT 180 OF 1972.

WHEREAS, Public Act 180 of 1972 provides for the direct purchase from vendors or suppliers of goods, materials, and/or equipment without compliance with existing and otherwise applicable statutory requirements governing competitive bidding and execution of contracts providing the Municipality pass an appropriate resolution permitting a municipality to participate in or purchase of contracts for goods and materials, or equipment entered into by the municipality; and

WHEREAS, the Municipality of Penn Hills has passed a resolution awarding contracts;

WHEREAS, the Municipality of BOROUGH OF NORTHUMBERLAND is requesting it be authorized to participate in purchase contract/s of the Municipality of Penn Hills and agreeing we will be responsible for payment directly to the vendor under such purchase contract; and

WHEREAS, the Municipality of BOROUGH OF NORTHUMBERLAND, COUNTY OF NORTHUMBERLAND, Commonwealth of Pennsylvania, is desirous of participating in this type of purchase.

NOW, THEREFORE, BE IT RESOLVED, that at a public meeting duly convened by PRESIDENT OF COUNCIL and BOROUGH SECRETARY the Municipality of BOROUGH OF NORTHUMBERLAND are requesting that the Municipality be permitted to participate in the purchase of contract/s of the Municipality of Penn Hills.
