

**BOROUGH OF NORTHUMBERLAND**

**ORDINANCE NO. 2010-6**

**AN ORDINANCE OF THE BOROUGH TO ESTABLISH A TIME OF  
REMOVAL OF YARD SALE AND/OR SPECIAL EVENT SIGNS AND TO  
PROVIDE PENALTIES FOR VIOLATIONS THEREOF**

BE IT ORDAINED AND ENACTED by the Northumberland Borough Council,  
as follows:

Section 1. Definitions.

The following terms shall have the meanings indicated:

- a) Yard Sale – shall mean any public sale of goods on residential property including, but not limited to, the residential properties, garage, home, lawn or yard;
- b) Special Event – shall mean any private or public occurrence that is advertised on any sign, flyer, poster or bulletin
- c) Borough – shall refer to the Borough of Northumberland

Section 2.

Any individual, group, or corporation conducting a yard sale or special event within the Borough or outside the Borough limits or any individual, group, or Corporation posting advertisements within the Borough limits for a yard sale or special event to be held inside or outside the Borough limits shall remove from within the Borough right-of-way all signs, flyers, posters, and bulletins no later than 48 hours after the yard sale or special event. Should the yard sale or special event for any reason not be held all signs, flyers, posters, and bulletins advertising the yard sale or special event must be removed no later than the scheduled last day for the yard sale or special event.

Section 3. Violation

Any person who shall violate any provision of this Ordinance shall, upon conviction thereof, shall be subject to penalty as adopted by Resolution.

Section 4. Enforcement

Any police officer is hereby authorized to act on behalf of the Borough.

Section 5. Severability

If any provision, sentence, clause, section, or any part of this Ordinance is for any reason found to be unconstitutional, illegal, or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Ordinance. It is hereby declared as the intent of the Borough Council, that this Ordinance would have been adopted had such unconstitutional, illegal, or invalid provision, sentence, clause, section, or part thereof not have been included herein.

Section 6. This Ordinance shall take effect immediately upon its enactment.
